LOCAL AGENCIES HAVE BEEN REQUIRED TO ADOPT WATER EFFICIENT LANDSCAPE ORDINANCES...

The Water Conservation Act of 2006 (AB 1881) requires that all local agencies, not later than January 1, 2010, adopt Water Efficient Landscape Ordinances for new and existing landscapes to promote the conservation and efficient use of water and to prevent the waste of this valuable resource.

All new construction and rehabilitated landscapes for public agency projects and private development projects, and developer-installed single-family and multi-family projects, with a landscape area equal to or greater than 2,500 square feet, requiring a building or landscape permit, plan check or design review must comply with these new water conservation ordinances.

All new construction landscapes which are homeowner-provided and/or homeowner-hired in single-family and multi-family residential projects with a total project landscape area equal to or greater than 5,000 square feet, requiring a building or landscape permit, plan check or design review; existing landscapes (limited); and cem-

eteries (limited) are also required to comply.

If your project falls under one of these included categories, depending on your location, you may be required to submit a water efficient landscape worksheet package including a hydrozone information table, estimated total water use calculations ("ETWU"), maximum applied water allowance figures ("MAWA"), and controller timingscheduling charts, along with your irrigation design plan. After installation, you may also need to submit a certificate of completion, an irrigation auditing report, and a proposed maintenance schedule.



The Water Efficient Landscape Ordinance aims to promote the conservation and efficient use of water and prevent waste of such a valuable resource.
